Fluid Flow is very important to restore the functions of the organs' parenchyma, to fight chronicity and pain, to activate the active principle of natural remedies in our organism, and to stimulate the healing process. First, Andrew Taylor Still, DO showed the importance of CSF, then Sutherland, DO and Becker, DO with the relations between the Breath of Life and the dynamic of the fluids and liquids. Miller was especially involved when he presented the role of the lymphatic system to his colleagues. Philippe Druelle, DO has developed summaries on the functions of fluid flow and demonstrated the biomechanical, biodynamic, and especially bioenergetic links between the different functions of the liquids and fluids in human physiology with clinical applications. A new field is beginning to take shape in Osteopathy by establishing the relations between the dynamic of the liquids and the quantum level of living matter, which is also related to emotions. This seminar will be focused on practice to better treat and master the free circulation of the fluids and liquids, as well as to improve the quality of homeostasis in patients.

## PRACTICE-BASED SEMINAR

- The functions of the dynamic of the fluids. The relationship with the autonomous nervous system and the vagus nerve. Its importance in tissue regeneration, including neurons. Clinical examples with children.
  - The role of the artery is absolute. Practice to normalize the vascular tree and relieve pain. \*\*\*
  - The importance of fluid flow for homeostasis and to fight the inflammatory process and stimulate immune defense. Clinical examples and methodology for the work on the lymphatics. Palpatory evaluation of inflamed tissues and proposal of techniques to stabilize the hypersensitivity of tissues and achieve normalization.
  - Palpation of the fluids and liquids at the level of the brain, heart, and parenchyma. Direct therapeutic action on the function of the organs. Practical examples on the liver, the pancreas, and the kidneys.
  - Evaluation and treatment at the biomechanical level for the micronormalization of the joints. \*\*\* New concept and proposal of a model showing the importance of the vascular tree in the alignment of joint structures. Evaluation and practice, example with the main vascular trees: the brachiocephalic artery and the shoulders, the carotid and the vagus nerve, the vertebral artery for the cervicals and the occiput/atlas/axis for the cerebral circulation and the movements of the different parts of the brain, the iliac arteries in groin strains, sciatica, and the aortic arch for upper thoracics and pulmonary health.
  - Work on the different strategic areas. The diaphragm, the cisterna chyli, the ganglionic chains \*\*\*
  - The importance of the heart and the notion of stasis, friction and inflammation. Relation with the sympathetic and parasympathetic system. Practice on the normalization of frictions.
  - Role of the sympathetic-parasympathetic balance in the dynamic of the fluids.
  - The work of Miller DO. His work and the principal maneuvers. \*\*\*
  - The work of Becker. The dynamic of the fluids and the Breath of Life. \*\*\*
  - New developments on the dynamization of the active principle that stimulates tissue health. \*\*\* A therapeutic method will be given for each of the following items:
    - Heart and brain. The blood-brain barrier (vagus nerve and viral infection)
    - Brain and microbiota. Behavioral and psychiatric disorders.
    - Brain and uterus. Fertility and the functions of hormones and the fluid flow.
  - The work of the kidneys, more specifically the kidney and the adrenals in relation with the fluid flow and the heart and brain in the newborn and the adult.
  - The fluid flow and the dynamic of the dura mater with the jellyfish effect \*\*\* the bioenergetic notion and the quantum level. Therapeutic application.
